PRISM IS A 501(C)(3) NONPROFIT ORGANIZATION FOUNDED IN 1970 BY COMMUNITY MEMBERS CONCERNED ABOUT LOCAL HUNGRY AND HOMELESS FAMILIES. WHAT STARTED AS AN INFORMAL EFFORT HAS SINCE EVOLVED INTO A STRONG, SUSTAINABLE ORGANIZATION THAT IS CONSIDERED A LEADING PROVIDER OF BASIC NEEDS SERVICES IN THE NORTHWEST SUBURBS. OUR MISSION IS TO PROVIDE SOCIAL SERVICES AND CONNECTIONS THAT EMPOWER PEOPLE IN OUR COMMUNITY TO BUILD HEALTHY, STABLE LIVES. OUR CORE VALUES OF COLLABORATION, INNOVATION, DIGNITY AND ACCOUNTABILITY GUIDE OUR WORK. THE CONTINUED GENEROSITY OF THE COMMUNITY ENABLES US TO MEET THE FOOD, CLOTHING, AND HOUSING NEEDS TO NEARLY 7,500 LOW-INCOME CHILDREN, ADULTS, AND SENIORS EACH YEAR. THE MARKETPLACE FOOD SHELF ENSURES CHILDREN, ADULTS, AND SENIORS DO NOT GO HUNGRY. TRADITIONALLY, PRISM USED A "CHOICE" MODEL WHERE INDIVIDUALS GET TO SELF-SELECT THEIR OWN FOOD AND HYGIENE PRODUCTS. A TOTAL OF 2,790 HOUSEHOLDS VISITED THE FOOD SHELF BETWEEN 10/1/20-9/30/21. IN ADDITION, WE DISTRIBUTED 1,046,947 POUNDS OF FOOD BETWEEN 10/1/20-9/30/21. SINCE COVID, WE CONTINUE TO MODIFY OUR FOOD DISTRIBUTION MODEL. IN MARCH 2020, WE BEGAN DISTRIBUTING FOOD USING A DRIVE-UP MODEL, WHILE PARTICIPANTS WAIT SAFELY IN THEIR CARS AND PRISM STAFF LOAD TRUNKS AND BACKSEATS WITH A WEEK'S WORTH OF GROCERIES.
